Immediate Spill Cleanup: Promptly remove spilled materials, food remnants and packaging debris to minimise attractants.

☐

Surface Sanitation: Regularly clean floors, machinery and equipment surfaces to prevent pest harbourage and contamination.

☐

Access Control: Ensure all entrances, loading docks and overhead doors are fully sealed during non-operational hours. Implement air curtains to prevent flying insects from entering.

☐

Inventory Inspection: Regularly examine incoming and outgoing goods for signs of pest infestation or damage. Reject compromised shipments.

☐

Leak Prevention: Detect and repair plumbing, roofing or equipment leaks to eliminate water sources for pests.

☐

Proper Waste Handling: Utilise closed containers for all waste materials and ensure timely removal of refuse. Store waste away from building perimeters.

Storage Area Upkeep: Organise storage spaces, elevate materials off the floor and maintain clear aisles to allow for inspections and treatment.

Surface Examination: Look for visual signs of pest activity, such as droppings, gnaw marks, rub marks or insect casings. Inspect storage areas, equipment and structural elements.

Drains and Pits Check: Keep drainage systems, floor drains and trenches clean, functional and free of debris to prevent pest breeding.

Cooling and Dry Storage Checks: Inspect walk-in coolers, freezers and dry storage areas for signs of pest nesting, such as shredded materials or insect activity.

☐ **Structural Sealant:** Inspect utility entry points, wall penetrations and foundation cracks. Seal any visible gaps or openings with rodent-proof materials.

☐ **External Environment:** Look for active burrows, trails or other evidence of pest activity in the surrounding landscaping or outdoor storage areas.

☐ **Facility Surfaces:** Conduct detailed inspections of loading bays, storage rooms, equipment housings and structural supports.

☐ **Storage and Waste Zones:** Thoroughly clean storage rooms, loading dock areas and dumpster enclosures. Remove all signs of nesting, debris or spilled materials.

☐ **Building Perimeter & Exterior:** Check walls, roofing, loading docks and the building perimeter for any openings or points of entry.

☐ **Container Integrity:** Inspect trash receptacles, recycling bins and outdoor storage containers. Ensure they are intact, properly sealed and well-maintained.
